Waiver: In consideration of being permitted to participate in any way in the

APALI Youth Leadership Summit on Saturday March 28, 2015 at Yerba Buena High School,

hereinafter called the "The Activity," I, for myself, my heirs, personal representative or assigns, do hereby release, waive, discharge, and covenant not to sue the Asian Pacific American Leadership Institute (APALI) and De Anza -Foothill College District, its officers, employees, and agents from liability from any and all claims including the negligence of APALI's Board, its officers and agents, resulting in personal injury, accidents or illnesses (including death), and property loss arising from, but not limited to, participation in The Activity

Severability: The undersigned further expressly agrees that the foregoing waiver and assumption of risks agreement is intended to be as broad and inclusive as is permitted by the law of the State of California and that if any portion thereof is held invalid, it is agreed that the balance shall, notwithstanding, continue in full legal force and effect.

The undersigned waives the right to inspect or approve versions of my or my child's image taken at The Activity used for educational or promotional purposes. I understand that my or my child's name will not be used unless I so authorize below. I further understand that I will not be compensated for the permission that I am granting here. I release the hosting organization and its agents from any claim that may arise regarding the use of these images, including any claims of defamation, invasion of right to privacy, rights of publicity or personality, or copyright.
